Dear Arkansas AAOHN Members,

The AAOHN Foundation Board of Trustees would like to take this opportunity to personally thank the leadership and members of the Arkansas Association of Occupational Health Nurses for contributing funds to the Foundation. We know this was a difficult decision for the chapter which was made after a great deal of hard discussions. We are very sorry that your chapter has dissolved, but most grateful that the funds were given to the AAOHN Foundation so that we can collectively make a difference for our AAOHN members by awarding scholarships and educational grants.

The Arkansas Board of Directors has established the AAOHN Foundation Richard G. Johnson Memorial Scholarship, available to eligible Arkansas AAOHN members. This award will grant two (2) scholarships (\$1500 each) to attend the AAOHN 2025 National Conference, and two (2) scholarships (\$1500 each) to attend the AAOHN 2025 Conference of Leaders. Eligibility is simple. You must be an Arkansas resident with at least one year of AAOHN national membership. Submit the application below by email prior to the February 1<sup>st</sup> deadline, identifying your event preference (National Conference or Conference of Leaders). We will hold a drawing to select the lucky winners and notify recipients in February. This award must be used for the AAOHN Conference of Leaders, March 29-30, 2025 in Pittsburgh, PA or the AAOHN National Conference, March 31-April 2, 2025 in Pittsburgh, PA. Award recipients will receive notification of complimentary registration for the selected event. The scholarships cannot be applied to any other AAOHN event or program.

**Be sure to apply by February 1st, 2025. This is a firm application deadline.**
